The language issue is one of the sources of conflict that led to the war. During an exhibition game in Ottawa between the Czechs and the Russians in the early 70s, one of the Russian players was skating circles around his Czech opponents; he was one of the best if not the best in the world. It was an exhibition game, so my guess is, this Russian superstar, [I believe Boris Mikhailov], let his guard down, and a Czech defence-man obliterated him with an elbow to the head. He was on the ice for a long time, maybe a career-limiting assault. Possibly political vengeance for the Soviet invasion of 1968. There will be opportunities for both Russians and Ukrainians and other combatants to act similarly.

However, the Czech-Russian incident happened partially because the Czechs were being routed by the Russians. The same national pressures will not be in place with mixed teams.

The disabled athletes from the war zones will take a prominent role and should have a tempering effect on all athletes and the audience. Still, coaches and administrators from all countries, as well as the event organizers, will instill in the players the idea that this Olympics is about fun, community involvement, health and an end to the hostilities. Incidents, both the good and the bad, should be logged into the AI database along with the background and reasoning behind the incidents. Interviews with players, fans, trainers, and coaches will create a data base to better understand human psychology. It will develop forms to assist people integrating into the mixed-team format for both the international and local competitions. **Pilot Events:** Before a full-scale Integrated Olympics, smaller pilot events will test the concept, refine rules, and iron out logistical issues. Universities could pioneer this. They could work with other countries that have an interest in resolving differences: Israel – Palestine, US – Iran...

Canadian and American Universities could get together for a long weekend to study this new sports phenomena. A series of questions would be asked each player about the opposing teams before the matches begin. On Friday teams play two half games in regular formation. Players wear recording devices and after the game are asked questions individually, in a team setting, and in mixed team settings. On Saturday they play 4 half games as integrated teams. In the evenings, discussions similar to Friday. On Sunday two regular half games with discussions. Party Sunday.

The universities involved should be those with bitter rivalries. Where players on one team don't see the players on the other side as having any dignity as human.

AI could be used to identify and synthesize successful peace efforts from other areas of the world, and develop new approaches to the Integrated Olympics. Other countries have used art, music and theatre effectively. The new AI, e.g. Google's Bert will cross-model between sports, arts, science, and humanities, enabling each field to expand its ability to service the human perspective.

The Integrated Olympics, which includes arts and science, will be a tool to bridge the gap between different sides of a conflict, allowing them to come together and find common ground. It will provide a creative outlet for those involved on a variety of fronts.

•**Peace education programs for children:** These programs would teach children about the importance of peace and understanding between people from different cultures and backgrounds. They would also teach children how to resolve conflicts peacefully. This, and the following programs would be part of the full-scale Integrated Olympics.

Humanitarian assistance and cultural exchanges will help on a personal level.

**Privacy and Security Concerns:** Collecting feedback from citizens, especially in a conflict zone, might raise significant privacy concerns. A public idea-intake centre at local universities and community centres, similar to vote casting during elections, can be designed for those who wish to submit their views privately. Eventually, and with the appropriate innovative facilities, people will find a way out of these difficulties.

**Establishment of Ceasefire:** To promote peace negotiations, the combatant parties will agree to a ceasefire for a specified duration, preferably 4-5 years. During this time, all disputed territories will be designated as international zones, and all weapons of war will be relocated at a distance agreed upon by both parties. WUK, an arts collective in Vienna, and World Peace and Relief Team played an instrumental role in making this tour a reality. Those participating in this tour were invited to lead a seminar at Foreign Affairs, inaugurating a change in Canadian foreign policy: a program was to be initiated to support artists in war zones.

Children are sacred, much of our society revolves around them. World Vision, War Child, and similar organizations, along with schools around the globe, have a myriad of experiences. AI can now synthesize the best experiences of children worldwide and blend them with the goals and vision of a particular culture. Teachers have a huge influence in the community, and in the journey to find a peaceful solution.

New communications technology is transforming the Zoosemobile such that musicians and interactive participants can see and play with participants at other musical sculptures located in different cities and countries. The tour was extraordinarily successful but could have been much better had the children of Bosnia been able to connect with children elsewhere. The AI and the new digital technology can do this, controlling lights and volume, assisting participants to follow any beat.

Sounds become music when people are listening to each other. Musicians, often icons in local communities, understand the necessity of listening with more than just one's ears. They will be the Pied Pipers for good relations as they were in 2000 when two Jewish and two Palestinian musicians from Canada sang a traditional Palestinian song in each other's language at the Festival in Haifa. AI will be used to assist all those participating to understand the human element in music.

The tour in Haifa took place in response to Ariel Sharon's ill-fated visit to a mosque he wasn't invited to. This was a grave insult to the Arab community. We had hoped that our visit and the continuing work after the visit would have been a veiled apology by the West to the Arab community. To let the Arab and Muslim community know that there are some of us they could place their hope in.

We proposed to the mayor of Haifa, Amram Mitzna, to have a sister-city relationship between a Palestinian city, Toronto, and Haifa. For electronic music sculptures to be built in all three locations such that Palestinians, Canadians and Israelis could see each other outside of the box that some of the

politicians put people in. Amram agreed. Unfortunately the Mayor of Toronto was Likud and the mayor of Haifa was Labor. The Mayor of Toronto opposed the proposal. The lack of a voice for peace led to the suicide bombings in the Tel Aviv Market. Unfortunately, a precedent-setting event.

The Interactive musical sculptures will help to bring all combatants in the disputed territories into the new emerging interconnected world. Ely Lyonblum, Strategic Research Development Officer at the University of Toronto, and the Islamic Information Center is assisting with a project to connect Haifa, Toronto, and a Palestinian City. This work can be transferred to Ukraine and Russia.
